



RULES

CASHIER HOURS: from 09:00 to 12:00 and from 16:00 to 19:00

CHECK-OUT HOURS: by 10:00 a.m.

- All campers, upon arrival, must fill in the appropriate notification form, fill in the privacy card and show proof of identity.
- **For safety reasons, as required by fire regulations, the entire perimeter of the pitch must not be occupied. Customers are obliged to keep a distance of 55 cm from the perimeter. In the event of failure to comply with this provision, they will be held liable to criminal penalties, fines, and damage to property and persons.**
- The barriers within the campsite remain closed from 12:30 to 15:30 and from 19:30 to 08:30. During these times it is strictly forbidden to enter and exit with cars and motorbikes, and to set up and/or take down tents.
- From 14:00 to 15:30 and from 24:00 to 07:00 all noise that may disturb rest is prohibited.
- Cars are only permitted on the day of arrival and the day of final departure to allow for unloading and loading of luggage. During the stay, cars must be left in the assigned parking space. Cars that do not respect this allocation will be removed with a tow truck. The parking space assigned to the Management, where provided, cannot be changed.
- It is absolutely forbidden to enter the facility with animals.
- Only intact, rubber-coated, seamless cables may be used to connect to the camp site power supply in accordance with current regulations. In case of absence, it is mandatory to disconnect the socket from the power supply.
- It is absolutely forbidden to mount on verandas or extensions of them, cannicci or raised concrete from the same roots.
- The administration is not liable for damage to property and/or persons caused by protruding roots or concrete tiles raised by the same roots.

- The administration shall not be liable in any case for theft of money or objects, nor for damage to cars, caravans, nor for damage of a natural order (falling branches, pine cones, etc.), nor for traffic accidents, which occur within the campsite or the (unattended) car park. Each camp guest is obliged to look after his/her own property.
- Visitors are not accepted unless previously announced and authorised by the reception. If authorised, they must leave their documents on arrival and pay the daily rate for visitor access.
- It is strictly forbidden to plant nails, tie ropes or otherwise damage trees and plants.
- For greater hygiene, rubbish bags must be tied up and deposited in the waste disposal area located in the car park.
- Anyone finding any object in the campsite enclosure must hand it in to the reception, who will return it to its rightful owner.
- Lighting fires, digging holes or pits is strictly forbidden.
- Use of the playground, swimming pools, various equipment and participation in entertainment activities is at one's own risk.
- Any form of dumping and/or sewage from tents or caravans, washing awnings, verandas and gazebos in the campsite facilities is strictly forbidden.

FAILURE TO RETURN THE CHIP WILL RESULT IN A CHARGE OF € 20.00.

IT IS FORBIDDEN TO SEPARATE THE ELECTRICITY CARD FROM THE KEY OF THE BUNGALOW/VILLINO, UNDER PENALTY OF WITHHOLDING THE DEPOSIT OF € 100,00.
